Job Purpose:

Under the general direction of the Area Electrical Engineer; to supervise contractors/repair and maintenance teams undertaking periodic inspections of plant and equipment, and to value and certify payment for work completed. To also carry out inspections of electrical (power, lighting, control and lift installations) in City Council establishments with a view to identifying particular defects or malfunctions and recommend appropriate remedial action.

Main Duties and Responsibilities:

1. To ensure that periodic inspections of installations and equipment in City Council establishments, undertaken by contractors & in-house staff, are carried out in accordance with agreed frequency and programme.
2. To Investigate proposals to repair, alter, or extend existing installations, recommending appropriate modifications where required.
3. Prepare specifications/working drawings/tender documents as necessary, to undertake proposal to repair, alter or extend existing installations.
4. Prepare detailed reports on the condition of installation and plant inspected, identifying defects and maintenance requirements and recommending appropriate remedial action to ensure the safety of the user.
5. Initiate appropriate urgent action where installations or plant do not comply, including the immediate isolation/taking out of service any dangerous installation/plant to ensure the safety of the user.
6. Provide support to the Senior Compliance Engineer to ensure the high level of inspection routines required in ensuring the safety of users and general public.
7. Preparation of technical and other reports as required on the safety aspects of the Electricity at Work Act, LOLER Regulations
8. Liaise as necessary with other members of the Compliance and Surveying Team in order to co-ordinate visits of inspection where appropriate.

9. Organise inspection programmes to ensure minimum disruption of engineering services to the user.
10. Attend meetings with Officers of the Compliance and Surveying Team and others as required, to ensure the co-ordinated organisation of work.
11. Liaise with Service Managers in order to maximise understanding of client needs in relation to inspections, and to ensure client awareness of how and when inspections are to be carried out.
12. Prepare statistics / reports relating to inspections as required.
13. Ensure that all necessary service and certification documentation relating to installation and plant, etc is maintained, accurately filed and is up to date.
14. To ensure Quality Systems of operations are followed.
15. Communicate effectively with other sections and divisions, with City Council departments and with customers.
16. To provide high quality standards of customer care.

Any other duties and responsibilities within the range of the salary grade

The post holder must comply with Coventry City Council's health and safety policy and in particular is required:-

- To take reasonable care for their own health and safety at work and of those who may be affected by their actions or by their omissions
- To cooperate with their line manager and senior management, to work safely, to comply with health and safety instructions and information and undertake appropriate health and safety training as required
