# About the Service your team will provide

### Purpose of the role / Output

At all times, to promote and safeguard the welfare of children and care leavers who live or access services in, or who are looked after by, Coventry City Council.

Working as part of a children looked after and care leaving service with social workers and professionals to deliver a high quality and effective service. A particular focus on supporting and improving outcomes for unaccompanied asylum seeking children (UASC) and young people.

- To act as a personal Adviser to a specified number of young people and be their first point of contact, with responsibility for providing flexible support and advice when they are preparing and planning to leave care, and throughout their transition to adulthood when they access the aftercare service
- To provide care, support and guidance to children in care and care leavers (up to age 25 years) and enable them to develop the life skills and confidence to live independent adult lives.
- The role would also require close liaison and support to social workers and other agencies. Liaison with local UASC support services, the Home Office, Legal Advisers as necessary to ensure positive outcomes for unaccompanied asylum seeking children and care leavers and input into the UASC policy.
- To advise line manager of any unmet needs, service deficits, resource implications and unresolved issues.
- To work within the framework of legislation, departmental policies and procedures.
- To work within the budgetary and resource constraints applicable.

# Main Duties & Key Accountabilities

### **Core Knowledge**

• To provide direct support, within a flexible approach to the time that a service is delivered, to unaccompanied asylum seeker children and young people preparing to leave care and to support them in gaining their independence within the community.

- To hold case responsibility for young people aged 16 -25 who have left care in relation to the management and review of their individual pathway plans.
- Develop and maintain a full understanding of government initiatives to help young people entitled to After-Care services to make informed choices on the range of learning and employment opportunities available to them.
- To develop relationships with all professionals working within key organisations and agencies, and also to advocate for and on behalf of care leavers to ensure they receive appropriate services.
- To provide information on/liaise with other agencies and organisations to develop/build on young people's community support networks.
- To maintain accurate written records and files in line with CCC IT systems and Data Protection/Information Governance policies.
- Contribute to the collation of management information by ensuring that information is recorded accurately and promptly on our database to allow monitoring progress towards targets.
- To attend strategy meeting/child protection conferences, family group/support conferences, reviews and planning meetings when necessary.
- To build links in the community so UASC receive information about services they can access locally in the city. A key element of the programme will be to work with community groups to embed this work in the local community so it is sustainable.
- Coordination of UASC drop-in sessions to provide young people with support and advice with issues that affect them and an opportunity to network with other young people. This will include support with applications for leave to remain and development of independence skills such as budgeting, cooking, managing a tenancy.
- Group work will be delivered to focus on key issues such as the health needs of young people and to encourage them to remain/ return to education or training.
- Co-ordinate and minute regular multi-agency UASC panel. The role of the panel will be to ensure that the correct reporting for the Home Office is being carried out, that all UASC are getting the required support and services.
- Co-ordinate weekly UASC legal sessions.
- To liaise with UASC to ensure that the correct applications are with the Home Office and applications are made within timescales.

- To pro-actively support UASC directly and through Social workers to ensure they access benefits that they are entitled to as soon after they are in receipt of recourse to public funds
- To feed into local UASC policy to ensure that the Local Authority has fulfilled its corporate parenting duties.
- To maintain an overview of young people who are UASC. Support social workers in identifying necessary training and support opportunities.
- To ensure weekly data is sent to UASC administration team in respect of any new UASC.
- To have a good working knowledge of the Age assessment process and Merton Compliance to be able to assist and advise Social Workers and Personal Advisers.
- Input and retrieve data from the service areas designated ICT systems to assist with the collation, monitoring and reporting of statistical
  information for the purposes of performance management, returns to Central Government and information for other agencies including those
  internal to the organisation as appropriate.
- Maintain detailed knowledge of all relevant legislation, statutory guidance and case law relating to housing, issues concerned with housing, and corporate parenting responsibility. Apply this knowledge to the duties in this post.
- Attend Training courses as required
- Any other duties and responsibilities within the range of the salary grade.
