

Job Description

Sports and Outdoor Activity Coach Grade: 4

Job Purpose

A qualified and enthusiastic sports coach, with specialist experience and/or training of planning and teaching Physical Education to Primary aged learners.

Work Pattern:

42 Weeks - 37 hours per week (38 weeks Term Time plus 4 weeks; 5 INSET Days & 3 Weeks Holiday Club)

Duties and Responsibilities

Under the direction and supervision of the PE Leader:

- Ability to demonstrate a clear understanding of good Primary practice.
- Commitment to the principles of Assessment for Learning.
- Teach Physical Education lessons across the primary ages.
- Promote physical exercise and activity within the after school and holiday club provisions
- Set tasks which challenge pupils and ensure high levels of interest.
- Evaluate own coaching critically to improve effectiveness.
- Have an understanding of and a commitment to working within the school's policies and the National PE Curriculum.
- Demonstrate experience of and ability to carry out short, medium and long term curriculum planning and assessment and a commitment to doing so, according to the policies of the school.
- Assess how well learning objectives have been achieved and use them to improve specific aspects of teaching;
- Monitor pupils' achievement and set targets for progress;
- Be able to demonstrate good organisational skills in keeping children's records and evaluating children's progress and achievements.
- Able to demonstrate an understanding of the coach's role and responsibilities in promoting and supporting positive behaviour within lessons and throughout the school.
- Be able to communicate effectively with adults and children.
- Prepare and present informative reports to parents.

- Have an understanding and commitment to promote equal opportunities in all aspect of school life.
- Be able to demonstrate evidence of excellent subject knowledge and expertise in Physical Education.
- Promote the welfare of children and to follow the child protection procedures adopted in the school's Safeguarding Policy.
- To attend, and when appropriate lead, professional development and planning meetings and contribute to the whole school's planning activities.
- To have a commitment to enhancing the school's sporting/healthy lifestyle profile through supporting: active playtimes, the creation of a number of school 'teams'; planning and delivering Partnership sporting festivals; running after school clubs; assemblies, displays, website etc.
- Be prepared to lead school teams outside the regular school day. (If applicable, additional payments would be made in such an event.)
- To work collaboratively with the school's PE Leader & Headteacher
