To support in the effective, efficient, customer focussed delivery of the Street Lighting Private Finance Initiative (PFI) Contract including working with the Service Provider in delivering, monitoring and enforcing performance in accordance with the contract. Provide technical support on all aspects of public lighting.

# Main Duties & Key Accountabilities

- 1) To assist in the management of the contract in accordance with the prescribed timescales, performance standards and specifications as defined in the Project Agreement, Output Specification, Method Statements and schedules.
- 2) To carry out robust change management protocols updating changes such as new legislation, accruals/de-accruals, lighting standards and initiatives and new technologies within the Contract documentation.
- 3) Contribute to the implementation of measures for improving service delivery when required; notifying the Traffic & Road Safety Manager of any value for money opportunities and to participate in dispute resolution.
- 4) Provide technical advice to the Traffic & Road Safety Manager and Service Provider in the development of the Core Investment Programme (CIP) of lighting installations, with particular regard to the review and approval of lighting design schemes and similarly with developers and consultants in respect to Section 38 and 278 works during the CIP and ongoing.
- 5) Conduct surveys, site measures and post work inspections and liaise with both the Service Provider and the Independent Certifier as necessary. To undertake night inspections and photometric testing as required. To monitor progress and analyse performance.
- 6) To contribute to the improvement and effective management of systems, procedures and interfaces to support high quality service delivery, asset and performance management both within the Contract Management Team and in the Service Providers delivery of the PFI Contract.
- 7) To generate and interpret management information reports from corporate and service provider systems for analysing, measuring and monitoring performance. The production of reports and other such communications.
- 8) To undertake a partnership approach when working with the Service Provider, Independent Certifier and other stakeholders and to deputise for the Traffic & Road Safety Manager at internal and external facing meetings, seminars, forums and other relevant events as necessary.
- 9) Keep abreast of new and existing legislation such as National Roads & Street Works Act, Traffic Management Act 2004 and Highways Act 1980; new technologies and asset management techniques in respect of Street Lighting Activities.
- 10)To provide technical advice in response to complaints and members enquiries and to participate in the investigation and resolution as appropriate.

- 11) To review and provide advice to the Traffic & Road Safety Manager on the certification of the monthly Unitary payment to the Service Provider ensuring that correct contractual costs, charges and savings have been identified and applied in accordance with the performance standards and the payment mechanism.
- 12) To participate in the auditing of transactions, procedures, payment and systems to ensure the service provider is delivering value for money and compliant with the contract terms and conditions.
- 13) To ensure that all income generating activities provide to third parties such as fees for Section 38 and 278 works etc have been recharged or invoiced, keeping a full audit trail of activities, time and materials etc.

To deputise for the Traffic & Road Safety Manager as appropriate

14) Any other duties and responsibilities within the range of the salary grade.
