- 5. Promote the grants and business support elements of the Economic Development Service to SMEs in Coventry and Warwickshire. Working with all other relevant business support partners to ensure key business support services are communicated.
- 6. Provide a senior advice and support role giving high-level guidance, advice and training support on good practice in how the Council and the Local Enterprise Partnership should respond to economic development opportunities, specifically inward investment related.
- 7. Specifically support the Council in maximising economic benefit from the city council's

relationships with major external bodies such as Department for International Trade, West

Midlands Growth Company, C&W Chamber of Commerce, Coventry University and University of Warwick.

- 8. Represent the Council and the Local Enterprise Partnership when hosting potential investors and overseas delegations.
- 9. Work alongside a Business Development Manager to ensure external funding requirements are monitored, achieved and reported.
- 10. Actively work with service managers to identify and secure external funding resources to deliver service objectives now and into the future work of the division and directorate.
- 11. Build relationships with council colleagues relevant to inward investment in order to ensure a cohesive and comprehensive service is offered to potential investors.
- 12. Deliver inward investment opportunities, through a variety of means, including exhibitions, presentations, media work and events.
- 13. Maintain links to a variety of internal and external partners for the purpose of inward investment service development.
- 14. Any other duties and responsibilities within the range of the salary grade.
